I voluntarily give this waiver and release intending to legally bind myself and my heirs, representatives, successors and assigns.
 - If, during the course of my participation in the Adopt-A-Park program or otherwise, I notice any situation which I believe causes significant risk or injury to myself or others, I will promptly notify the Public Services office in writing. I understand that I will not be compensated for the use of the name(s) and photograph(s) of my children, and will hold the City of Midland harmless in its use thereof.
